Community energy organisations are key in making sure the energy transition works for everyone, and that the economic benefits are translated to social and environmental benefits in communities. To us, community energy organisations are a critical partner in shaping the energy sector to work better for increasingly active customers.

Foreword

Our vision is for a thriving community energy sector, supported by strong networks that link the voluntary sector with expertise in the energy sector, anchor institutions, local governments, and others. We are therefore pleased to refresh our Community Energy Engagement Strategy for the next two years, up to 2025. Since 2020, when our first Community Energy Engagement Strategy was published, we have seen a lot of change, with a significant increase in local organisations forming and exploring community energy projects, as well as groups seeking to play an active role in tackling the climate emergency in their local communities.

Stakeholder consultation

64 community and local energy stakeholders consulted through an online survey. Community **Energy Forum and Community** Energy Stakeholder Panel to get views on this strategy.

In 2020, our Community Energy Engagement Strategy set out 26 commitments to support the sector from 2020 to 2023. Three years later. the increased activity and feedback have meant we are delivering even more support. While we see more community energy organisations coming forward, the pace at which new projects are being delivered is slower. It is important that policymakers, the energy sector and other key actors understand the key barriers that community organisations face and work together to resolve them.

As a key anchor organisation in our region to facilitate net zero, this strategy sets out our vision for supporting a thriving community energy sector over the next three years. We are already making efforts to address some of the barriers faced by the sector - by offering additional support to help new organisations access expertise and capacity through our Net Zero Community Energy Fund, and through engaging and linking up with other community organisations in their area, which they can find through our 'Put your community on the map!' campaign.

There is also more work ongoing with partners and community energy project funders to bring our engagement programmes and resources together, helping organisations navigate the information and resources available, and collaborate with each other. As we enter our next business plan period up to 2028, 'RIIO-ED2', we're shifting the needle in our approach to local decarbonisation, proactively encouraging community energy projects through a new team of community-based energy advisors and rolling out innovative solutions to a smart, low carbon energy system, suggested and trialled by local community energy organisations.

In this strategy, you will find our commitments both continuing and refreshed - for community energy in our region, as well as a snapshot of what's been achieved so far and how the sector is looking in the North East, Yorkshire and Northern Lincolnshire.

## **Community Energy in our region**

Our region has seen a significant increase in local organisations forming and exploring community energy projects, as well as groups seeking to play an active role in tackling the climate emergency in their local communities.

We have commissioned two regional studies to support our work, in 2019 and again in 2021. These were in-depth analysis of community energy across the North East, Yorkshire and northern Lincolnshire. This research was conducted by Community Energy England, Scotland and Wales as part of their annual Community Energy State of the Sector UK research project. The enthusiasm for locally-led action on energy issues remains, and those driving the sector are highly engaged and committed to exploring new opportunities.

Over the course of the Community Energy Engagement Programme from 2020 to 2023, the community energy sector in the North East, Yorkshire and northern Lincolnshire has grown and diversified the range of activities it delivers. Whilst the challenges of the COVID-19 pandemic and the removal of subsidy support had impacted its progress, the sector continued to flourish.

## Net Zero Community Energy Fund Case Study: Northallerton Methodist Church

Northallerton Methodist Church, in North Yorkshire, was awarded funding to pay for development costs associated with gaining permission from planning authorities for solar PV, thermally efficient windows and heat pumps in four churches across the district. They are keen that this project helps them to demonstrate that Net Zero is possible for church buildings.

## **Community Energy in our region**

Just under 30% of all newly registered community energy organisations in the UK were formed in the Northern Powergrid region in 2021.

State of the Sector data from previous years showed that community energy activity in the Northern Powergrid area had been lower than in the rest of the UK, so this is a positive sign that awareness of the benefits of community energy is increasing, and communities are actively mobilising to deliver these benefits.

Based on the installed capacity, the amount of electricity generated by community energy projects across the region in 2021 is estimated to be around 3.3 GWh – equivalent to the electricity demand of 1,100 UK households (assuming Ofgem's annual average usage of 2,900 kWh).

Northern Powergrid were the first DNO to set up a Community Energy Seed Fund in 2014, and in 2018 they merged funds with Northern Gas Networks to create the Community Partnering Fund. In 2022, Northern Powergrid launched a new, additional Net Zero Community Energy Fund aimed primarily at capacity building and support for organisations at the early stages of developing projects. We have run this Fund again during 2023. In total we have given out £100,000 of funding to directly support 15 communities with their net zero goals.



#### Net Zero Community Energy Fund Case Study: Humshaugh First School Governors

Humshaugh First School Governors applied for funding to contribute towards the costs associated with installing air source heat pumps to replace the existing oil boiler at Northumberland-based Humshaugh First School. As a result, the air source heat pumps are now installed and heating the school effectively.

<u>Net Zero</u> Community Energy Fund Northern Powergrid, as the network operator, is responsible for employing people and investing and maintaining the electricity infrastructure in the North East, Yorkshire and northern Lincolnshire.

**Community Energy and ED2** 

Electricity networks are known as 'regulated monopolies'. Ofgem, as the regulator, sets out how much we can spend, and on what, over a period of time called a price control period (typically spanning five years). These costs are then passed through energy suppliers who add it to customers' bills.

We develop business plans for these periods which are reviewed and agreed by Ofgem. The plans set out how we will efficiently deliver value for customers through investment and innovation to deliver a low carbon energy system with stakeholders at the heart of this process and the decision-making. For more information, see Electricity Network Association.

We have now agreed with Ofgem our business plan for the price control period (called ED2) between April 2023 and 2028. Climate change and the cost of living are critical parts of our new business plan, which means changing how we run our business. We will be taking a leading role in enabling our region to play its part in meeting the UK's target of reducing carbon emissions by almost 80 per cent by 2035. We know our network will be instrumental in facilitating this change, as it sits at the heart of a decentralised, low carbon energy system. We will be working across that whole system to find innovative ways to deliver on that target.

We offer community organisations the opportunity to apply for in-kind support or grants of between £1,000 and £10,000 to support communities across the North East, Yorkshire and northern Lincolnshire on their net zero journeys. The purpose of this fund is to support projects at the early stages, explore feasible project ideas, enable access to the right expertise, and encourage new and existing community energy organisations to develop their project ideas. In 2022 and 2023, we have awarded more than £100,000 to 15 organisations in our region.



## York Community Energy

York Community energy is a community organisation that aims to reduce York's carbon emissions. This includes, among other things, conducting energy assessments of residents' homes and providing advice and support to those in fuel poverty. They are using the funding to pilot an extension of the existing Warmer Homes York assessment service, to turn it into a One-Stop-Shop for residents who are able to pay for low carbon retrofits.

## LILAC

LILAC is an award-winning community housing project in Leeds that stands for Low Impact Living Affordable Community. They are using the funding to pay for one year of in-depth feasibility work with a local housing energy expert organisation, to support the transition of community-led housing to net zero. The feasibility work will specifically explore what community-level and multi-home solutions are feasible that can enable the transition to net zero homes in a way that is affordable and replicable.
