

Schedule of Contestable Input Services

As part of our ongoing commitment towards maintaining an environment in which Independent Connections Providers (ICPs) can compete freely and fairly to undertake contestable works, we included an action within our 2017/18 Incentive on Connections Engagement (ICE) plan to publish a range of contestable input services available to ICPs.

The following table provides a list of these contestable services, which are available to ICPs in instances where either the ICP does not hold the relevant National Electricity Register (NERs), or Northern Powergrid's accreditation/authorisation, or is unable to secure its own resource to carry out the contestable elements of a new connection.
