

## August 2020 Investing £1 million in Scarborough

Dear Customer

Northern Powergrid, the company responsible for the network that powers everyday life for 8 million customers in the North East, Yorkshire and northern Lincolnshire, is about to start a major investment programme to improve the reliability and resilience of the electricity network in your area.

The **£1** million investment focuses on replacing 7km of high voltage underground electricity cabling dating back to the 1960s with a more modern and sustainable alternative. This new cabling will be capable of meeting the existing demand for power as well as any future increase in demand as the population grows and more people swap their cars for electric vehicles.

We're working in partnership with **North Yorkshire County Council** and our appointed contractors, **O'Connor Utilities** and **Murphy Utilities** and, together, we're committed to minimising disruption wherever possible for local residents, businesses and visitors.

### Where and when we'll be working

From 24 August 2020 until the end of 2021 we'll be excavating in the road along the following route.

We'll be working on sections of Salisbury Street, Seamer Road, Oak Road, Falsgrave Road, Mount Park Road, Cambridge Place, Valley Road, Londesborough Road, All Saints Road, Westover Road, Belgrave Terrace, Westwood, Westbourne Grove, Princess Royal Terrace, Princess Royal Park, Fulford Road and Filey Road.

We're not planning to turn off anyone's power and it's unlikely we'll need access to premises. We'll also be making sure that we maintain pedestrian access for residents and ensuring that businesses can make arrangements to continue to receive deliveries.

## **Coronavirus (COVID-19)**

We're following Public Health England advice to keep our employees, contractors and our customers safe and as such all our work is carried out in line with the latest COVID-19 health and safety practices. As a result we're asking customers not to approach our teams if they see them working in their local community unless it's an electricity emergency – and if they do to maintain two metre social distancing at all times.
