## Our Spring 2024 tender is now live.

This is the first of three tenders this year.

We are seeking to procure 5MW flexibility services across 19 locations in Yorkshire and the Northeast.

#### **Flexibility Requirements**

The service windows are for Winter 24/25 and Winter 25/26.

We are procuring the pre-fault Scheduled Utilisation product to manage demand constraints at two primary substations and 17 distribution substations, so our requirements are for demand turn-down or generation turn-up.

Additionally, we are looking for expressions of interest at a further five locations for 2025/26, 2027/28 and 2031/32. These locations are for visibility purposes only.

#### Key dates for your diary

- Deadline to confirm asset entry into competitions: noon Thursday 16 May (or noon Monday 3 June for visibility only competitions)
- Bidding window: noon Friday 17 May to noon Monday 3 June



#### What's new

We have adopted the latest industry wide work on standardisation of flexibility products. We are now procuring the new 'Scheduled Utilisation' product which is similar to and replaces the 'Sustain' product that we have procured previously.

We had also intended to adopt the latest industry standard contract for flexibility services. However, the extended stakeholder consultation process means that this "version 3" isn't yet available to use so we will be contracting on the same terms as our previous tender. We expect to adopt version 3 for our next tender round.

Bidders are to propose a baseline as part of the tender process and provide accompanying narrative to explain the proposed baseline. This information should be uploaded via Piclo Flex as part of the bidding process, before the bidding window closes.

#### Did you know ....

.... that you can specify a 'maximum runtime' when submitting a bid? For example, If the competition service window is 4 hours long, but the longest your assets can deliver the service is 2 hours, you can still bid. Just specify a max runtime of 2 hours.

.... that you can register planned assets on Piclo? The data required is less detailed than for registering operational assets, and you can enter your planned assets into competitions.

.... that as well as viewing the competitions on the Piclo Flex dashboard, you can download data files with details of the competitions and their geopackage or postcode data on the 'documentation' tab here

### How to participate in our flexibility tender

Step 1: If you're new to Piclo Flex then create an account. Once you have your account, we recommend that you upload your flexibility assets. Find out more about uploading assets here.

Step 2: If your organisation is not already prequalified to provide flexibility services to Northern Powergrid, you should apply for company qualification before the Dynamic Procurement System (DPS) closes at noon on Wednesday 10 April. Find out more about the DPS application here.

Step 3: Once you have passed company qualification <u>and</u> uploaded assets in competition zones, you will be in a position to <u>complete</u> <u>competition qualification</u> i.e. to confirm entry of assets into the competitions you wish to bid into. The deadline for this is step is noon on 16 May.

Step 4: The bidding window opens at noon on 17 May and closes at noon on 03 June. Find out more about submitting a bid here.

We recommend that you read carefully the instructions to bidders document which is part of the suite of 5 tender documents on the 'documentation' tab of the Northern Powergrid profile page on Piclo.
